Re: \$250 to Williams & Bay due to pump station that froze up.

Re: \$394.18 to Kalkaska Plumbing and Heating for a new pipe due to gas leaks.

Re: \$145 to DTE Energy for Vans Lane property.

Outstanding Task List Discussion:

The Outstanding Task List from last month was discussed. New items were added for individual and Board follow-up.

Regarding the ongoing generator issues and our attempts for adequate resolution of the matter, Mr. Ravary will draft a letter of notice for our attorneys to prepare and send to Cummins, Bruce Ottee-Bridgeway, and Fleis & VandenBrink Engineering (F&V) to 1) replace the generator, 2) replace the engine on the generator, or 3) modify the warranty. Cummins offered a 3-year/1500 hour warranty which is not acceptable as it's already been 3 years. We will counter with a 1500 hour/unlimited warranty at no cost to us or if request is not addressed and when generator fails, we will pursue legal action.

Regarding the private residence with an outhouse: The sewer is hooked up to the kitchen sink but not to the outhouse. State regulations are specific that a property must hook-up if within 200ft. of a body of water. Messrs. Broering and Ravary will prepare a letter to the property owner that Grand Traverse County will be contacted regarding their requirement to hook-up.
